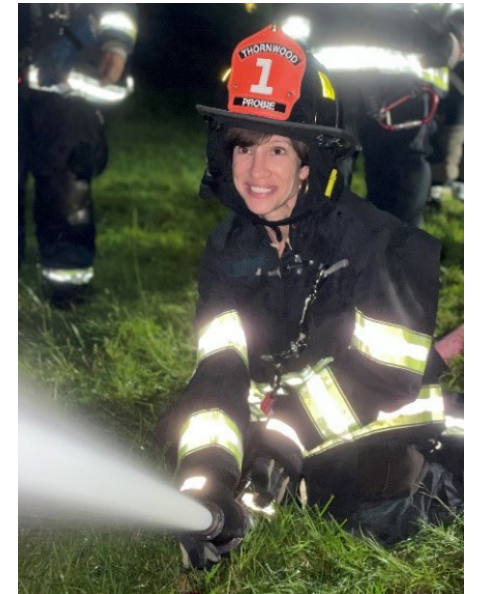


## LEGISLATIVE YEAR IN REVIEW

While the challenges of the last year have been significant, I remain committed to serving the residents of Mount Pleasant, North Castle, Pleasantville and parts of Briarcliff Manor, Greenburgh, and Sleepy Hollow.

Working in a nonpartisan manner as part of the Board's leadership team over the last year, I advanced legislative solutions with requisite funding to resolve longstanding issues, including the redesign of the Commerce Street and Elwood Avenue intersection in Hawthorne (scheduled to begin construction later this year) and the successful rehabilitation of George Washington's Headquarters/Miller House in North White Plains. I also supported a 2021 balanced budget that reduced the County property tax levy while maintaining funding for community-based organizations such as Hope's Door.

Recognizing the extraordinary work of first responders, especially during the pandemic, I delivered personal protective equipment (PPE) to volunteer fire departments and ambulance corps members, as well as local governments, throughout the year.



In December, I helped negotiate an agreement with Westchester County Health Care Corporation, owner of Westchester Medical Center, to provide ambulance services for five facilities on the County's Grasslands property, alleviating the burden of hundreds of calls on the Valhalla Volunteer Ambulance Corps. After Medicaid reimbursement, the contract comes at no net cost to Westchester taxpayers.

In addition to collaborating with local fire departments to develop and refine emergency response protocols at County parks, I realized a lifelong dream earlier this year by joining the Thornwood Fire Department as a probationary firefighter.

I serve on four Board committees this term: Public Safety (Vice Chair); Budget and Appropriations; Labor and Housing; and Planning, Economic Development, and Energy. As a member of the ArtsWestchester Board, I also secured Challenge Grant funding for local organizations such as ARC Stages, the Jacob Burns Film Center, and Historic Hudson Valley. I am always proud to advocate for the needs of our community. ■
