**Bronxville Footbridge Replacement Project**

Heeding the calls of eager residents wanting to take advantage of the County's award-winning parks system, the County announced the full replacement of the Bronxville pedestrian footbridge on the Bronx River Pathway located off Pondfield Road. The footbridge was destroyed during the remnants of Hurricane Ida, which passed through Westchester County last year. The bridge's abutments, borings, and deck were washed away during last year's flooding and will need complete replacement. This park's infrastructure upgrade also comes at my behest, who, like the County, heard from residents about the need to repair the footbridge. When my office received numerous correspondence on this issue, I knew we had a partner in the County Executive who was just a phone call away. Use of the County's extensive trail network is vital to the recreation residents enjoy and I am eager to see this project commence.



**UPDATE:** The Bronxville Footbridge is expected to finish construction in the next year. At this date, the project is still in the design phase. The Bronxville Footbridge Project is being funded from a FEMA grant.

I was thrilled to help raise \$4,000 in community funds for the Yonkers Police Department for all our precincts' National Night Out festivals. National Night Out is an important community-building event that promotes police-community partnerships and neighborhood camaraderie to make our neighborhoods safer.

On March 22, 2022, I became the first elected official in Westchester County to urge the state legislature in Albany to pass Gas Tax Relief via relieving or suspending the state sales tax at the gas pump during the “Gas Price Crisis of 2022”.

I was happy to join the County Executive and fourteen of my colleagues in suspending the County sales tax as gas pumps and other cost-saving measures during the Summer of 2022. The following were sent out in conjunction with the County Executive Office:

**GAS TAX HOLIDAY** – capping tax at \$.12 per gallon from June 1 – August 31, 2022

**SUSPENSION OF FEES FOR BEE-LINE BUSES** from June 1 – August 31, 2022

**FEE WAIVER FOR CIVIL SERVICE EXAMS** through December 31, 2022

**SUSPENSION OF WEEKDAY FEES FOR COUNTY POOLS AND GLEN ISLAND BEACH** from July 5 - August 31, 2022

## District 15 First Annual “Back to School Drive”

On August 25, 2022, I held my first annual “Back to School Drive” to help children in District 15 get the supplies they needed for the upcoming school year.

Our office partnered with St. John's Riverside Hospital, Yonkers Rotary Club, IAFF Local 628 Yonkers Fire Fighters, and Staples to help make this happen. Thank you to everyone that supported and helped make the Back to School Drive possible. I was happy to announce that we handed out 150 backpacks with supplies inside to students. The remaining backpacks were dropped off at schools within District 15 to help as many students and families as possible.



## Protecting Our Health, Safety and Well-Being

### REVISION TO LANGUAGE REGARDING PEOPLE WITH DEVELOPMENTAL DISABILITIES

This law amends various sections of the Laws of Westchester County, including the County Charter, to change the language used in reference to individuals with intellectual/developmental disabilities, and to employ the use of person-centered language to comply the person-centered approach used in policy and programs

### FOOD ALLERGY SAFETY TRAINING FOR RESTAURANTS

This law will ensure that restaurants have personnel on-site who have been trained in food allergy safety, including designated food safety officers during operating hours. Signs certifying employee training, outlining the nine major food allergies, and listing symptoms of allergic reactions with appropriate measures to take in cases of a reaction will also be posted.

### REPORTING OF HATE INCIDENTS

This law creates a process for the County's Department of Public Safety to keep track of hate incidents, in addition to the hate crime data it already assembles, as well as to report these incidents to the County's Human Rights Commission.

## Reopening to the Public

The Board of Legislators officially resumed in-person meetings on September 12, 2022. In order to provide equitable civic involvement, we instituted a hybrid model, requiring participants to register via Webex (an online teleconferencing system) to participate remotely and attend via livestream, as well as permit physical attendance for all of its meetings. Aside from its bi-weekly Board meetings, all County legislative committee meetings are subject to the new model. Information on

## Advocated for the Formation of the Westchester County Police SCUBA Team

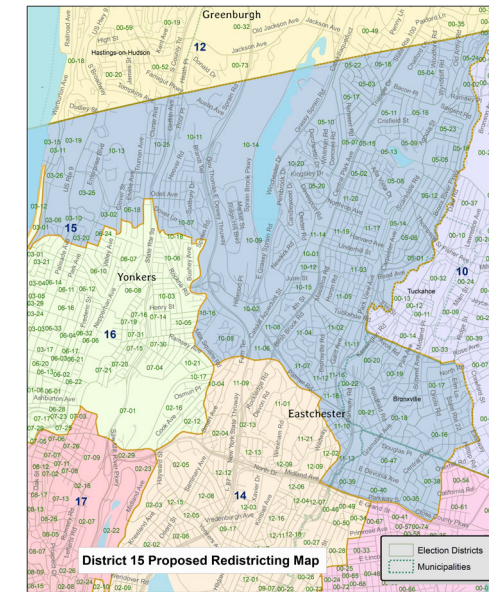
## Calling for Repairs at Sprain Ridge Pool

On September 29th, I called on my colleagues in County government to replace the Sprain Ridge Park Pool Building, which is falling apart, with a brand new facility. Over the summer, I spent a lot of time touring the Sprain Ridge Park's Pool Area. I was shocked to see that much of the Pool's infrastructure is in desperate need of repair. I am calling for a brand new building to be built at the pool. This building would consist of a food court area, bathrooms, locker rooms, a bathhouse, storage, and office space. As someone with a background in construction work, a new facility would complement the pool. Repairs to the building would



cost the taxpayers too much money, so instead a new facility should be built in its place. With the budget season coming up soon, the County should make this new building a number one priority. The County shouldn't wait until a pool goer is hurt by the failing construction. We should do this now before anyone gets hurt.

## Redistricting the County Legislature



A major undertaking at the Board of Legislators has been the process of reassessing Westchester County's 17 legislative districts, as is required every 10 years after a new census. We conducted 4 four public input sessions to engage residents in this important process. The 2020 U.S. census revealed that Westchester County's population had increased, putting us over the one million mark for the first time in our history. Because the increase is greater in some parts of the County than others, the work before us was to readjust our legislative districts so that the population of each was as equivalent as possible. We worked to ensure that our legislative districts reflect our local municipalities accurately, and account for our increased County population so that there was equity in representation for all our residents.
