One year ago, who would have imagined a global pandemic which would kill over 250,000 people in our country, devastate local economies, and leave far too many people without jobs or adequate food and healthcare? Families have faced unprecedented challenges – economic hardship, isolation, remote work while their children learn nearby, forfeited visits to elderly relatives, and sometimes illness and death. The challenges have been many, and have affected all aspects of our society and lives.

Despite these problems, I have been incredibly proud of our community and the strength and resilience that have been on display. Our first responders and healthcare providers worked tirelessly to keep our community safe and healthy. Businesses and nonprofits stepped up to provide food and services to needy families, and neighbors organized volunteer groups to ensure that no one went without food or basic supplies. Westchester County Budget

Westchester County has been hit hard financially by the impact of COVID-19. As in any unanticipated emergency, it is necessary for the government to expand its services at precisely the time when sources of revenue are most limited.

Fortunately, due to the county’s budget discipline last year, we had leeway in this emergency to respond rapidly to the dramatic loss of county revenue resulting from the pandemic – including reallocating \$10 million previously earmarked for the county’s rainy day fund. In addition, over 225 county employees opted to take advantage of a voluntary separation incentive in July.

Unfortunately, the pandemic has greatly reduced county revenue from sales tax and other sources. We expect to face difficult decisions ahead, absent substantial help from the federal and state governments.

2020 HIGHLIGHTS

AIRPORT

Development of the Supplemental Airport Master Plan was delayed due to the COVID-19 pandemic. In 2021, I expect extensive outreach to stakeholders and the general public to be incorporated into the master plan process as planned. The county took advantage of the reduced air traffic at the airport to move up the timeline to successfully complete the runway paving project. As of this writing, limited commercial flights have resumed and general aviation continues, but it will likely be some time before flight schedules are back to normal.

The Airport Advisory Board continues to meet remotely, and has had presentations from noise experts, air quality experts, and an expert on potential flight path modifications. Additionally, the County hosted a well-attended public information session with the FAA in January 2020.

INFRASTRUCTURE

Making capital improvements now, when interest rates are historically low, is a smart investment in Westchester's future. In October, the Board approved two Port Chester projects – the repaving of Westchester Avenue and the redesign of the dangerous intersection at Westchester Avenue and Regent Street. The design phase is underway for Union Avenue in Harrison and Willet Avenue in Port Chester. For the 2021 Capital Project Budget, I have requested \$2.9 million in funding to rehabilitate the Lincoln Avenue Bridge in Rye Brook.

STORM RESPONSE

Local power and telecommunications companies were tested when Tropical Storm Isaias ripped through Westchester in August. Unfortunately, preparations and response by these companies once again proved inadequate. My colleagues and I met with Con Edison and Altice (Verizon declined to meet) to discuss how they can improve services to our communities. While I do not expect changes overnight, it is important to let them know that we are paying attention and will not turn our backs on our constituents. One positive outcome of the meetings was the repair of the unsightly and unsafe pole on Meadowlark Drive in Rye Brook. If you feel something is unsafe in your neighborhood and you have not been able to get anyone to fix it, please contact my office and we will work with you to get it done.

ENVIRONMENT

As Chair of the Board of Legislators' Environment and Health Committee, I prioritized projects to combat climate change and create a more sustainable future for Westchester's residents. In 2020 we approved a plan to partner with municipalities to make food scrap collection more accessible and affordable. Food waste accounts for approximately 22% of the county's residential waste stream. By recycling food scraps into useful compost, we can reduce greenhouse gases and save money on trash disposal for our local municipalities.

Municipalities that offer a food scrap drop-off can now join a new county-sponsored program to collect and transport food scraps to our private partner for composting at a cost comparable to that of regular garbage disposal. Communities that choose to drop off their own food waste can do so at an even more reduced rate, saving substantial money.

I also lobbied for and the BOL approved a food scrap recovery and information center at the County's Household Material Recovery Facility in Valhalla. When the site opens in 2021, municipal leaders will be able to learn about setting up composting

sites in their own communities, which will further reduce our carbon footprint.

The county continues to replace old diesel and gas vehicles with hybrid and electric vehicles. In the first year of this process, we saved \$1,000,000 in fuel costs! This year the Board approved a plan to replace over 100 additional diesel buses with hybrid electric buses.

We also approved the installation of public-use electric vehicle charging stations in county-owned parking facilities to encourage cleaner transportation and to reduce carbon emissions. Additional charging stations will be added as the county builds or refurbishes existing lots.

YOUTH

One of the most hopeful and important aspects of my job is connecting with our youth, who bring fresh ideas and unique insights to every discussion. I encourage them to develop leadership skills and engage with local government. This year I had the opportunity to meet with young women at Ursuline School in New Rochelle, speak to a group of teen environmentalists in Greenberg and chat with the BBHS Political Action Club. I hosted a teen-focused virtual "Conversation with Legislator Barr" to discuss police reform and spoke with over eighty teens about voting and the census

I was pleased to connect with the Port Chester Youth Bureau Summer Interns, speaking with them about the role local government plays in their lives, watching their progress over the course of the summer as they immersed themselves in their work, and celebrating their successful completion of the program at their "graduation" dinner.
