2023 Westchester County Budget

- **MENTAL HEALTH:** The 2023 budget paved the way for the reopening of two mental health clinics.
- **CHILDCARE:** The parent share subsidy program has been decreased from 10% to 5%.
- **HEALTHCARE:** \$500,000 in American Rescue Plan Act (ARPA) Funds provided for neighborhood health centers throughout Westchester bringing the total to \$3 million in funding.
- **DIGITAL EQUITY:** Recognizing the importance of bridging the digital divide led to me supporting \$750,000 of funding being provided to Connect Westchester in an effort to increase connectivity in difficult corners of the County.

Our County is Growing and Changing

The AMERICAN RESCUE PLAN ACT (ARPA), Westchester County was allocated \$187,926,698 in March 2021 and received its second installment of \$93,963,349 in June 2022. The County has until December, 31, 2024 to disperse the funds according to the Federal guidelines, and has allocated them to these critical areas:

- Public Health Investment
- Healthy Mom, Healthy Baby Home Visiting Program
- Non-profit Grant Program
- Small Business Development Assistance
- Tourism & Hospitality Development and Promotion
- Workforce Development Job Training
- Affordable Housing Development & Multi-Family Unit Rehabilitation

- Wastewater Infrastructure
- Revenue Replacement

It is with great pleasure I share this opportunity of THE DOWNTOWN IM-PROVEMENT GRANTS (DIG) program offered in March 2023 for any municipality interested in applying and met all the following criteria:

- Municipalities are eligible if they do not receive direct CDBG funds from the Federal government or have not received a New York State Downtown Revitalization Initiative (DRI) grant in the past.
- Municipalities must be willing to participate in a joint collaboration (a contract or MOU may be required) between the local municipal government and the local Chamber of Commerce or other business organization.

• Local government must pass a resolution, to confirm their commitment to the program.

The Municipality of Pelham submitted an application, if selected The DIG Program will help the reimagine and revitalize their downtown economic engine through a program consisting of professional consulting and up to \$250,000 in implementation support. This is exciting news and more information will come in the near future. Each grantee will receive strategic one-on-one support to help grow consumer foot-traffic, retain existing businesses, recruit targeted-new businesses, provide training, and explore innovative new ways to strengthen and market their community through comprehensive analysis and a detailed action plan. ■

Working Legislation

The Clinic Access Law was passed, to ensure safe access to reproductive health care facilities. This law provides the right to access reproductive health care facilities and the right to obtain reproductive health care services and treatments. This is a personal right protected by our state. The right to peaceably protest and express one's views is an essential right protected by the state and federal law. Such constitutional actions include, the right to speak, march, demonstrate, picket and pray.

According to a 2018 Nature Magazine article, globally, more than 320 million tons of plastic are consumed every year, and the use of plastics has continued to expand. In 2019, National Geographic reported that plastic production has increased exponentially,

from 2.3 million tons in 1950, to 448 million tons in 2015; production will likely double by the year 2050. The manufacture of these plastics, made of petroleum and other fossil fuels, contributes to climate change and pollution. As we reduce, reuse, recycle my colleagues and I passed a local law on banning these items the plastic utensils, stirrers, splash sticks, and condiment packets, among other single-use food ware items are prevalent in Westchester require the candidate to certify that County and around the world.

sponsored by our Board is the "Truthful Disclosure by Candidates for Elective Office" Law. Following recent high profile misrepresentation of credentials and qualifications among those seeking office, this law requires additional

background information. The public can be confident that their elected officials have the experience, to effectively represent their constituency. It would require candidates for County Legislator and County Executive to complete a Candidate Disclosure Form that provides biographical information, including the candidate's educational, military, and employment histories. The Candidate Disclosure Form will also the information contained in the form Another key piece of legislation is true and correct. This form shall be open for public inspection, except for the month and day of the candidate's date of birth, the names of the candidate's minor children, and any information that is mandatorily required to be withheld under state or federal law.
