### 2024 Infrastructure & Housing Investments in a Snapshot

- 74 Affordable Units on Croton Avenue in Ossining: County is investing \$3 million toward the development of 74 affordable rental units in Ossining that will further fair housing and remain affordable for a minimum of 50 years.
- Public Safety Answering Points System (PSAP) Bond Act: A \$1.3 million investment to modernize 911 Call Centers that handle emergency calls and coordinate responses.
- FOOD SCRAP RECOVERY PROGRAM: Supported by a \$1.3 million capital project and Bond Act for the study, design, and development of a major composting facility to reduce County waste and generate valuable compost.
- BEE-LINE BUSES & BUS SHELTER RENOVATIONS THROUGHOUT THE COUNTY: The Board approved replacing 95 old 40-foot buses with new hybrid and all-electric models and upgrading bus shelters with solar power, ADA accessibility, and other improvements.
- 109 Affordable Units on Water Street in Ossining: County is investing \$4.36 million toward the development of 109 affordable rental units in Ossining at 30 Water Street that will remain affordable for a minimum of 50 years.
- \$1.1 MILLION INVESTMENT IN THE BLUE MOUNTAIN SPORTSMEN CENTER IN CORTLANDT: The Bond Act will finance the cost of design for the second phase of rehabilitation, including design of the main lodge, lodge addition and infrastructure improvements at the Sportsmen center including electrical service, water supply, sanitary system, communications and security, lighting, site drainage, roadway and pathway pavement and other associated site work and landscaping improvements.

### **Serving as the Chair of Labor & Human Rights Committee**

As Chair of the Labor & Human Rights Committee, I've brought together stakeholders to investigate challenges and opportunities, including:

• Briefing on the status of non-compete agreements in work contracts since the Federal Trade Commission (FTC) issued a final rule banning their use nationwide in **April 2024.** The FTC argues that noncompetes stifle wage growth and reduce choices for consumers. Every worker deserves the right to



leave one job behind for something better. Approximately 1 in 5 workers in Westchester County are directly impacted.

- Presenting before stakeholders on the benefits of Project Labor Agreements (PLAs): how PLAs are used to ensure the timely completion of capital projects while staying at or under budget; and the economic development, workforce development, and community benefits offered through PLAs.
- Inviting leaders from the American Jewish Committee (AJC) to present on the AJC's State of Antisemitism in America 2023 Report. The rise in antisemitism is extremely disturbing. No one should fear for their safety because of their religion. We will be working closely with the AJC, the County's Human Rights Commission, and other groups to address these challenges.
- Shining a spotlight on the reproductive harms felt across the industry for nail salon workers as reported by the New York Committee for Occupational Safety and Health (NYCOSH). The impact is felt predominantly by Asian and Hispanic workers that make up the majority of those in the industry. The coalition is pushing for statewide legislation to raise standards to protect these vulnerable workers.
- Promoting the NYS Department of Labor's dashboard: Exploring Occupations by Green Topic. This new feature on the DOL website includes 72 green topics and over 300 occupations offering comprehensive details on educational requirements, salary ranges, and the outlook for the number of positions in that field within the state. Whether your passion lies in renewable energy, environmental conservation, or sustainable agriculture, this resource can guide job seekers toward new career pathways and opportunities within the expanding green sector.

As part of my committee work, I am also advancing legislation to expand investments in apprenticeship programs and planning an apprenticeship fair for high school students. ■

## Domestic Violence Lock Changes Legislation

Everyone deserves to feel safe in their home, but what happens when your abuser has the key to the front door? This past year, the Board voted unanimously to pass the Safety Measures for Survivors of Domestic Violence Act which provides no-cost installation of new home locks and/or security cameras for domestic and gender-based violence survivors.

The Westchester County Office for Women will now be empowered to contract with designated community-based organizations to do the following:

- Conduct intake with survivors to determine program eligibility;
- Coordinate with licensed vendors regarding the installation of the dwelling safety measures (lock changes and/or security camera installation); and
- Conduct an education & outreach program to ensure survivors know about the program.

I was glad to co-sponsor this legislation, and I thank lead sponsor Legislator David Imamura for all of his work and advocacy. The Act was developed collaboratively with the Westchester County Office for Women, the County Executive's Office, and informed by the work of the Pace Women's Justice Center. ## **Securing Funding for Community Nonprofits**

## \$10,000 FOR OSSINING CHILDREN'S CENTER GIVING GARDEN PROGRAM

For over 20 years, OCC's Preschool Garden Program has provided children ages 3 to 5 with hands-on experience in planting, nurturing, and harvesting their own vegetable and herb garden. With this grant, the Giving Garden will extend the program to include elementary students in grades K-6. The children will plant, care for, harvest, and enjoy their vegetables while



learning about plant life cycles, the local ecosystem, and the nutritional benefits—and delicious flavors—of locally grown foods.

#### \$10,000 FOR CROTON CARING COMMITTEE'S FOOD BASKET PROGRAM

Croton Caring's Food Basket Program offers essential food support to families in need four times a year during school holidays—Spring, Summer, Thanksgiving, and Winter Breaks—when access to school meals is limited. Each family receives four to six boxes filled with perishables (such as milk, butter, eggs, bread, and meat) and non-perishable items for breakfast, lunch, dinner, and snacks. In December 2023, the program assisted over 300 local individuals, including 160 children.

# Office of Housing Counsel Expected to be Operational in 2025



In 2023, there were 8,264 eviction filings in the county. In response to this need, Westchester County created the Office of Housing Counsel to provide support to income-eligible residents facing eviction and other housing-related challenges.

Director George Asante presented his implementation plan for the office in

September 2024 and projected that the office will be operational in early 2025.

In July, thanks to constituent Geoff Haynes, I was glad to bring together Director Asante with Pace University's Legal Hand Call-In Center to discuss ways for the new County Office to best serve those in need.

I want to thank Director Asante for the diligence and heart with which he does this work. He has already been extremely helpful in doing all that's possible to help constituents in crisis who have turned to my office for support.
