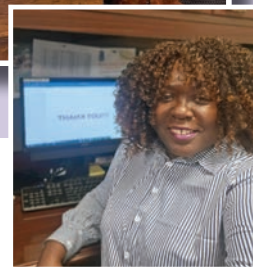


THANK YOU for Supporting Legislator Williams' 1st Annual 5K Run/Walk!

PUBLIC SAFETY

GUN VIOLENCE PREVENTION TASK FORCE: A recent CDC report shows U.S. gun deaths at a 30-year high, with firearm injury the leading cause of death among youth. Legislator Williams and County Executive Latimer launched a County-wide Gun Violence Prevention Task Force to address the vital issue.

SAFETY MEASURES FOR DOMESTIC VIOLENCE SURVIVORS: The Board passed legislation to provide free home locks and security cameras for survivors of domestic and gender-based violence. Developed with the Westchester County Office for Women, the County Executive's Office, and Pace Women's Justice Center, this Act enhances safety for victims.

STOP ARM LEGISLATION: This legislation will strengthen protections for children at school bus stops, in an effort to ensure their safety on the roads.

5K RUN/WALK: Leg Williams hosted the 1st Annual "Break the Silence On Domestic Violence" 5K Run/Walk at Tibbett's Brook Park on October 12th.

The proceeds of \$4000 were given to the YWCA of Yonkers to continue their Domestic Violence services and education. Save-the-Date: October 11, 2025 for 2nd Annual 5k Run/Walk at Tibbett's Brook Park, more information to follow.

INFRASTRUCTURE AND TECH UPGRADE

PUMPING STATION REHABILITATION

An \$18 million bond for improvements at the Mamaroneck Water Resource Recovery Facility to enhance infrastructure and efficiency.

ROADWAY CULVERT RESTORATION: This Bond Act finances a project to inspect and evaluate culvert structures along County roads. It will address flooding and determine necessary maintenance, rehabilitation, or replacement, establishing a priority-based schedule.

GREEN INITIATIVES

SOURCE SEPARATION AMENDMENT: This amendment updates the law to require separate waste and recycling bins in public areas and clarifies food

composting rules. By streamlining reporting and aligning with state hazardous materials laws, it simplifies recycling and waste management for businesses.

FOOD SCRAP RECOVERY PROGRAM: A \$1.3 million capital project and Bond Act for the study, design and development of a major composting facility to reduce County waste and generate compost.

BEE-LINE BUSES & BUS SHELTER RENOVATIONS: The Board approved replacing 95 old buses with new hybrid and electric models and upgrading bus shelters with solar power, ADA accessibility, and other improvements.

AFFORDABLE HOUSING (Chair, Leg. Shanae Williams)

LOCAL ANNUAL INCOME MEDIAN: The Act sponsored by Legs. Williams and Imamura, as well as, passed by the Board of Legislator requires the Planning Department to annually calculate and publicly share the Local Area Median Income (LAMI) for municipalities with available Census data. The LAMI calculations must be posted on the department's website, submitted to the Clerk of the Board, and sent to relevant municipal officials. This tool aids local leaders in affordable housing discussions.

HOUSING FUNDS: In September, the Board approved funding for land acquisitions, development, and rehabilitation in several municipalities: 528 rental units in Yonkers; 404 in Mount Vernon; 583

in White Plains; 128 condominiums in New Rochelle; and 180 rental units in Ossining. In total, 1,821 Affordable Housing units are planned with amenities like parking and community rooms, and marketed by income eligibility.

HEALTH AND WELL-BEING FOR RESIDENTS

A \$1 million bond will fund the reopening of a mental health clinic in White Plains. The clinic will offer essential support for individuals with urgent mental health needs, helping to meet the increasing demand for services.

"WESTCHESTER GROWING TOGETHER" is a new health equity initiative in partnership with United "Way of

Westchester offering caregivers bilingual resources and personalized tips for young children. It also provides children's mental health training for schools and providers.

RELIEF FOR HARD-WORKING TAXPAYERS

- **COUNTY PROPERTY TAXES REMAINS FLAT** for the sixth consecutive year.
- **SENIOR PROPERTY TAX EXEMPTIONS** excludes Social Security income from eligibility calculations, increasing relief for seniors with fixed incomes.
- **SUSPENDED BEE-LINE BUS FARES** for the third summer and holiday season.
- **NYS UNCLAIMED FUNDS** individual

legislator notification letters sent to constituents; four workshops were provided/sponsored by NYS Comptroller's Office, County Executive and Board of Legislators to assist residents in obtaining their funds.

GOOD GOVERNANCE

School Funding Restored: Proposed cuts to Foundation Aid by the Governor threatened to reduce funding by \$20 million across Westchester County's 40 public school districts. The Board held a press conference and wrote a letter to the Governor, opposing these cuts. Fortunately, the reductions were averted, and Foundation Aid funding was reinstated.
