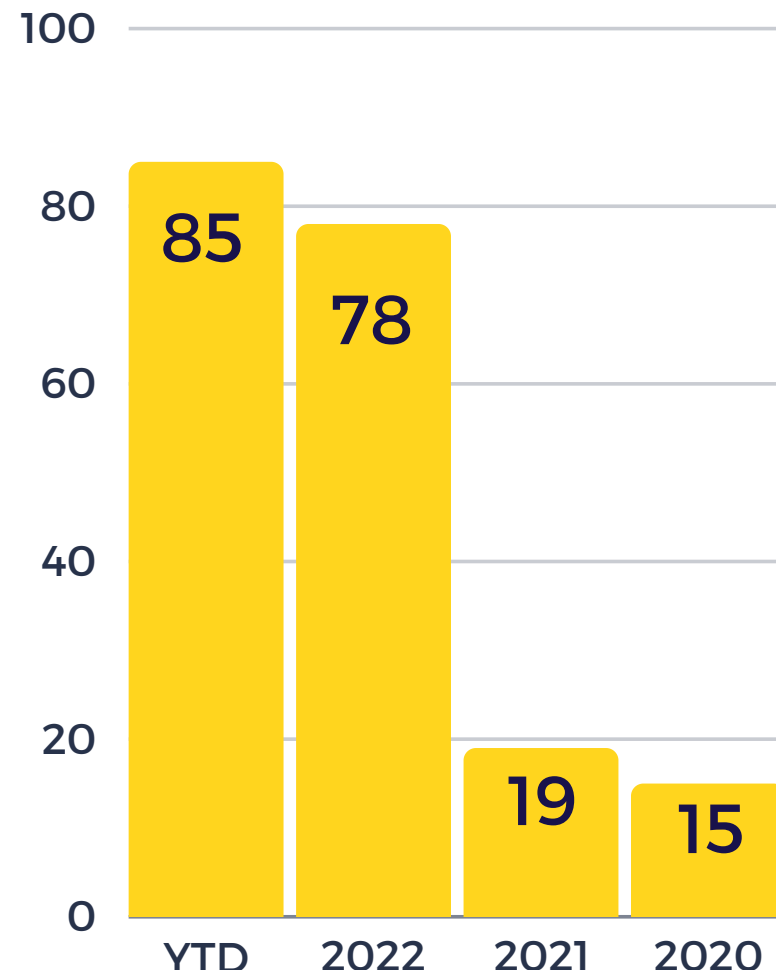

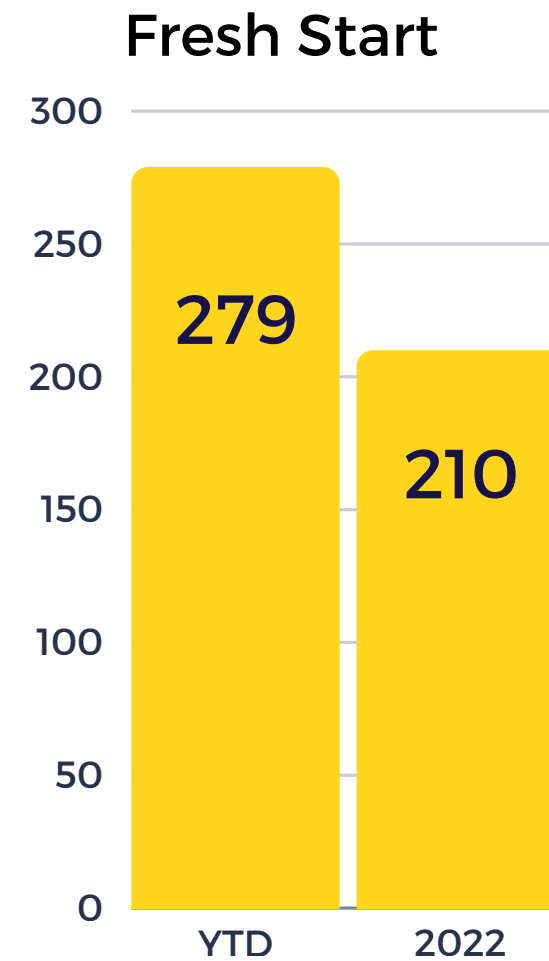

Highlights

Conviction Review Unit (CRU)

- **29 vacatur**
 - Exoneration of Leonard Mack - Longest wrongful conviction in U.S. vacated by DNA evidence known to the Innocence Project
 - 15 drug-related convictions/1 charge in Mount Vernon City Court
 - 11 drug-related convictions in Westchester County Court
 - 1 armed robbery conviction in Westchester County Court

Cold Case Bureau (CCB)

- 20 years-to-life prison sentence of Wanda Veguilla for the 2012 shooting death of her girlfriend Pamela Graddick
- May indictment for a 1995 homicide of Michael Jones at Sing Sing Correctional Facility
- 20 years-to-life prison sentence of Christopher Gonzalez for the 2005 strangulation murder of Angel Serbay
- 25 years-to-life prison sentence of Luis Alturet-Rivera for the 2017 shooting death of his ex-girlfriend Diana Casado
- Aug. 2022 indictment of Edmund Pennil for the 2017 death of Tremayne Williams
- Nov. 2021 indictment for the 1982 homicide of Kathleen Durst

Hate Crimes Portal

- **41** law enforcement agencies with jurisdiction in Westchester County now registered to the info-sharing portal since 2022 launch; expanding portal model to overdose cases

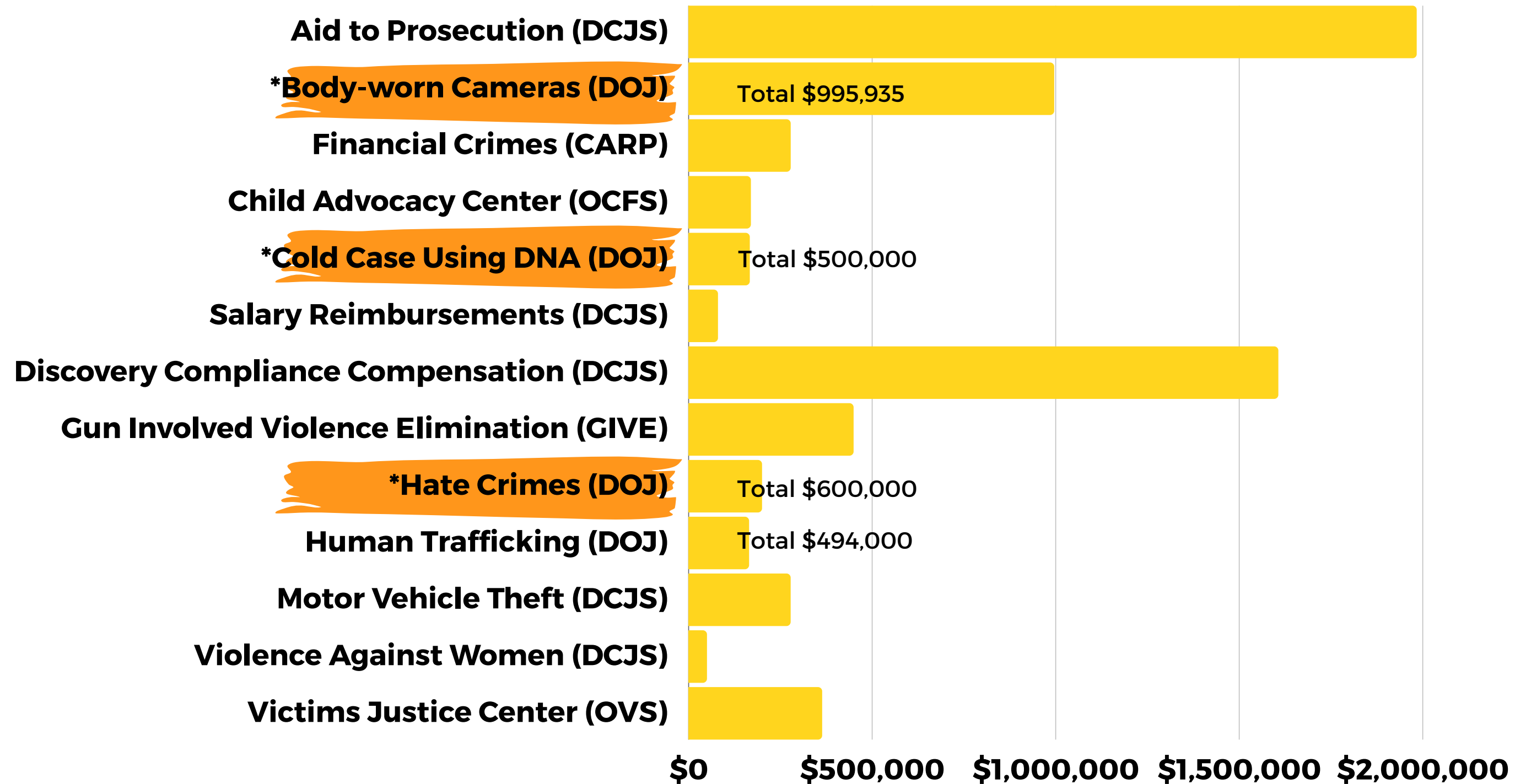

**New grants since 2021*



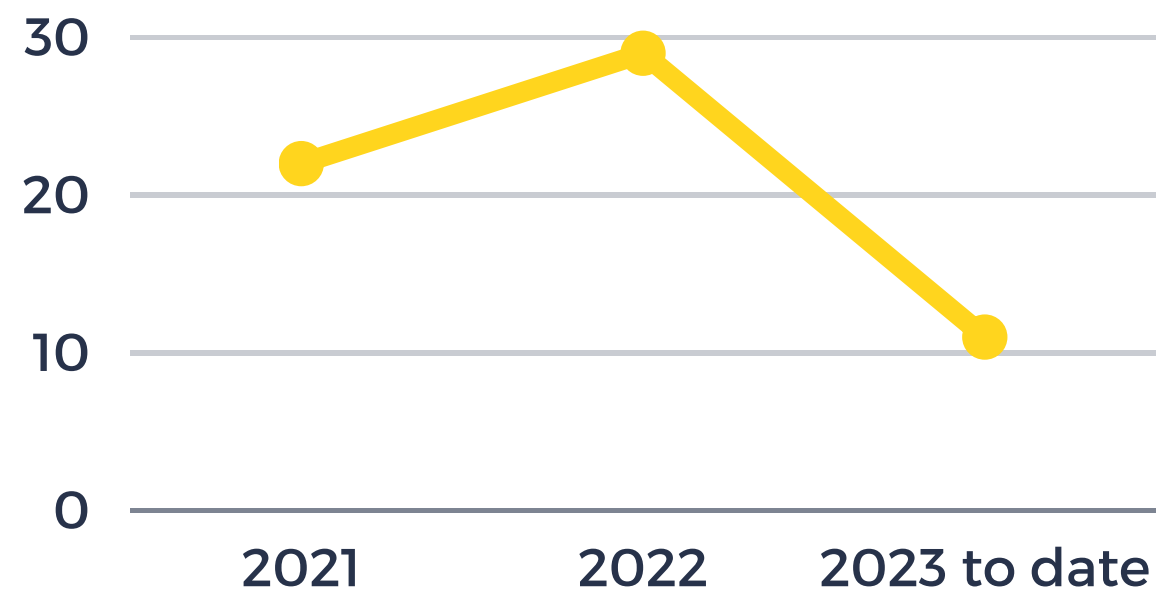
