**A177: Capital Budget Amendment:** Proposed Act amending the County 2007 Capital Budget by increasing the appropriations for Capital Project RP22A. [C231]

*B&A - Motion: Pinto; Second, Alvarado; approved 6-0 (for both A177 & C231).*

**C231: Bond Act:** Proposed Act authorizing the issuance of \$2,200,000 in bonds to finance Capital Project RP22A – Ride Acquisition. [A177]

*Voted out in conjunction with A177 (see above).*

#### **Joint with Public Safety & Security**

**A182: WCHCC Agreement:** Proposed Act authorizing the County of Westchester to enter into an agreement with WCHCC for comprehensive health care services to the inmates at the County's Department of Correction.

*B&A - Motion: Pinto; Second, Alvarado; approved 6-0.*

*PSS - Motion: Pinto; Second, Jenkins; approved 4-0.*
