**2008 DEPT. HIGHLIGHTS & ACCOMPLISHMENTS**

**Report on 2008:** Highlight of dept's accomplishments *(Usually in executive summary of dept budget)*

Held the first Stalking Conference in Westchester County with over 200 law enforcement personnel in attendance, partnered with the Office for the Disabled to create a program for Domestic Violence within the disabled community, expansion to six police departments of Electronic Orders of Protection Program, cross cultural outreach with the Hispanic Community and the Muslim Community, training on domestic violence for corporations and supervised visitation education and training initiatives and continued job training.
