**MEETING MINUTES**

**GOES Committee Members Present:** Hon. Michael B. Kaplowitz, Chair; Legislators Alfreda Williams, Judy Myers, Bill Burton, Bernice Spreckman, Ken Jenkins.

With a quorum present, the GOES Committee was called to order at 11:10 am.

**ITEM(S) FOR DISCUSSION:**

- **REVIEW OF PROPOSED COMMITTEE BLUEPRINTS**

The Committee members reviewed the proposed Blueprints (attached), and on the motion of Legislator Myers, seconded by Legislator Burton, they were approved 5-0.

- **CONTINUED DISCUSSION OF 2010 STATE LEGISLATIVE PACKAGE**

On the motion of Legislator Myers, seconded by Legislator A. Williams, the committee recessed to the call of the chair.

At 2:40pm, Chair Kaplowitz called the Committee back to order to discuss Early Intervention (EI) with Acting Health Commissioner Patsy Yang. Chair Kaplowitz stated that Commissioner Yang is a noted expert and respected resource and advocate on this topic. He also noted Assemblywoman Paulin's commendable work on this issue as well.

Commissioner Yang noted that one of the problems is that regarding EI, which is 0 – 3 years old, the County can exercise judgment in picking a provider from a state-approved list, however, with Pre-K, which is ages 3 – 5 years, the school district picks the provider and the County just pays the bill. For that we cannot bill commercial insurance, only Medicaid (which is very limited). For example, the County bills out approximately \$10 million annually for EI, but only receives between \$700,000 - \$800,000.

Ultimately, according to Commissioner Yang, the County should be out of this process completely – fiscally, programmatically and operationally. She is supportive of the Governor's bill to support the closure of commercial insurance loopholes in these areas.

A summary chart (below) comparing the Early Intervention and Preschool Special Education programs was provided by Commissioner Yang.
