## BIT41 Radio Tower Replacements New Project

Public safety radio tower structures at multiple locations require replacement in order to support existing, replacement and additional radio equipment vital to the maintenance and enhancement of coverage for public safety agencies as well as supporting primary connectivity for all radio systems and microwave communication systems. In addition, electrical systems replacement/upgrades are required at sites to facilitate the connections of emergency “portable” generator equipment should utility and primary generators become inoperable.
