PROPOSED LEGISLATION TO CHANGE THE DEFINITION OF GENDER IN THE HUMAN RIGHTS LAW

Legislator Bronz introduced proposed legislation to amend paragraph "9" of Section 700.02 of the Human Rights Law to change the definition of "gender" to mirror the definition of "gender" in the recently-adopted Fair Housing Law. The Members discussed the proposal; most thought the change was warranted to be consistent with the Fair Housing Law.

Legislator Bronz made a motion to approve the legislation, which was seconded by Legislator Nonna. Motion approved 8-0, with Legislator Oros voting without prejudice.

Legislator Oros made a motion to adjourn, seconded by Legislator Jenkins. Motion approved 8-0 The Committee adjourned at 1:15 pm.
