SOURCE SEPARATION REQUIREMENTS

(Maisano, Jenkins) Move for the Committee on Environment and Energy and (Harckham, Maisano) move for the Committee on Legislation to substitute the proposed local law which was approved by the committee's on May 5, 2008 to amend Chapter 825 with respect to Source Separation Requirements for Residential and Nonresidential Waste Generators and Penalties.

WESTCHESTER COUNTY TAX CODE REVISIONS

Gloria Fried, President and Patricia Columbo, Vice-President of the Westchester County Association of Tax Receivers and Collectors made a presentation of suggested changes to the Westchester County Tax Code. Many of the amendments are to bring the County law in line with current practices and remove any conflicts with New York State law.

Chairman Burton stated he will ask the Westchester Assessors Association to comment on the proposed changes. Over the next two months, he will ask the committee to review the matters and decide which amendments they would like to move forward with.
